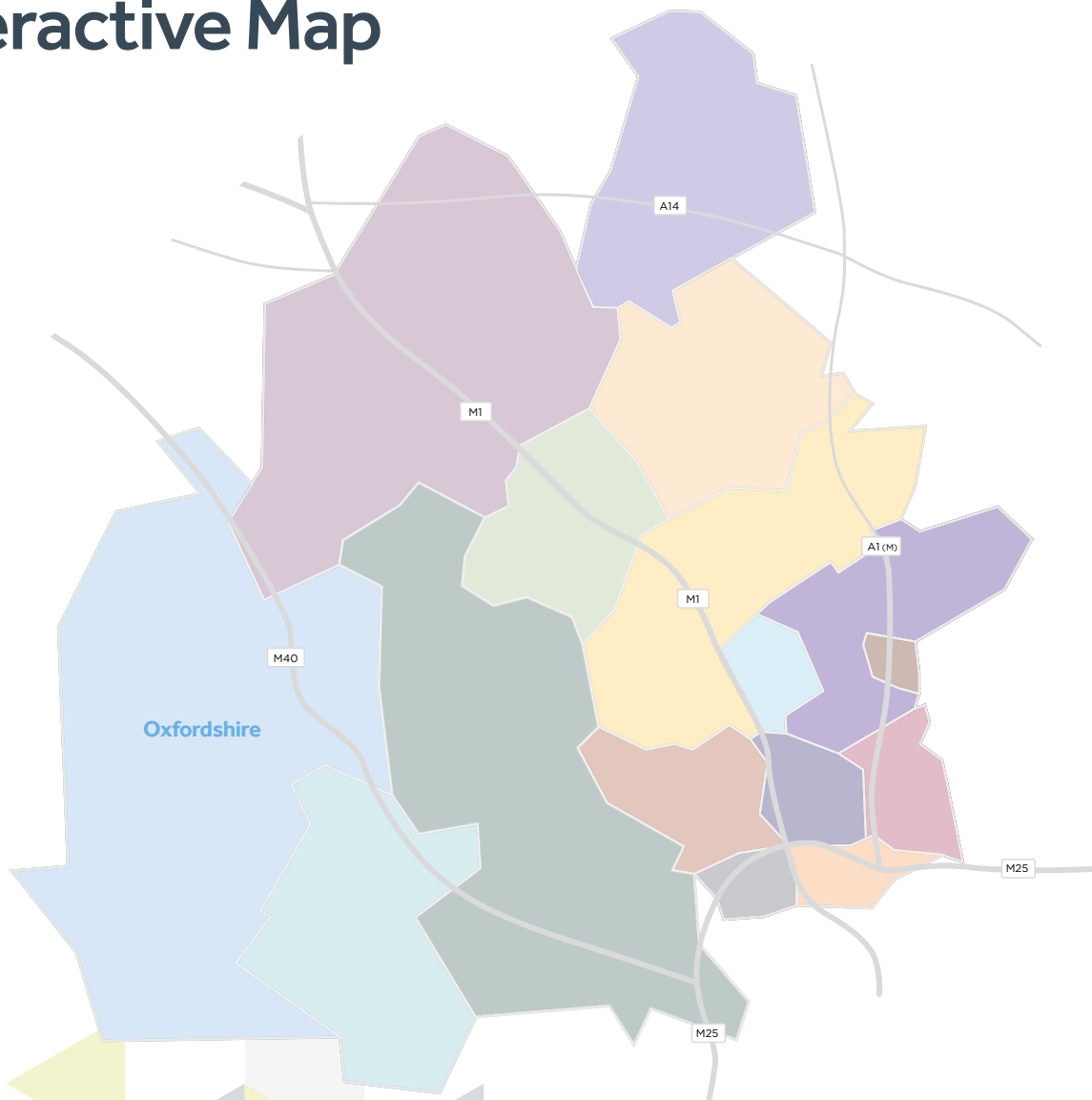

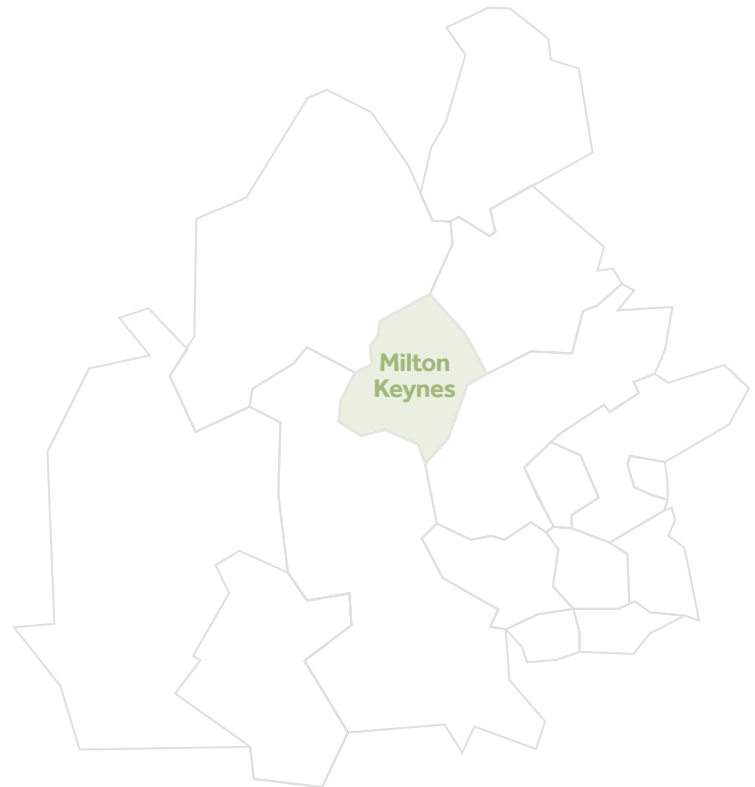

## Interactive Map



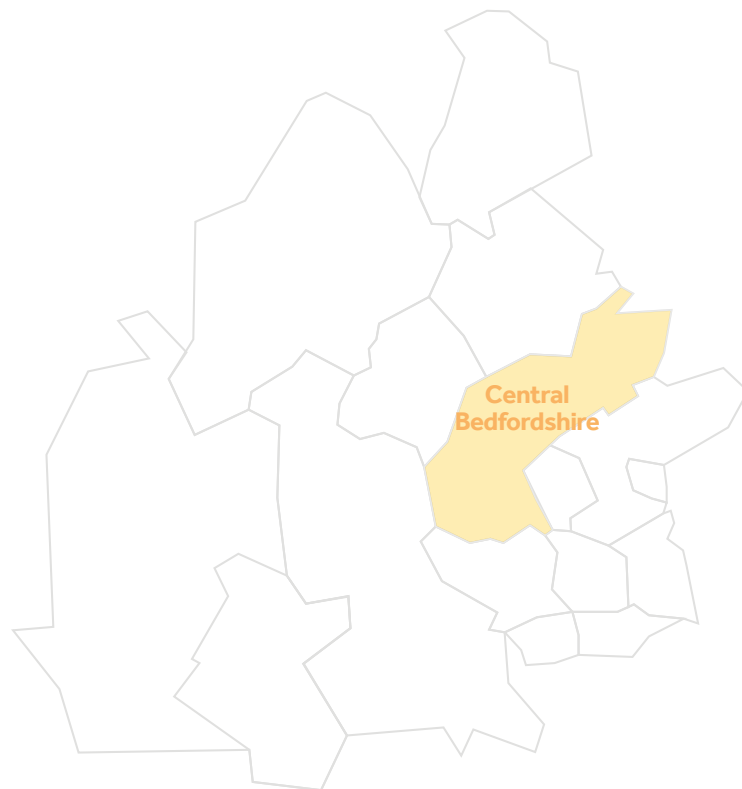
# Milton Keynes Local Plan

Milton Keynes Council have begun preparations for a new local plan, The New City Plan. The Call for Sites which was undertaken in early 2022 has been re-opened as of 13 February 2023 to enable further submissions to be made. The Council are in the process of carrying out the Stage 2 assessment of all sites within the Land Availability Assessment, a date for publishing the results is yet to be confirmed. A Regulation 18 consultation is programmed for summer 2024. If you think your land has development potential contact the Land Planning and Development Team for a discussion.



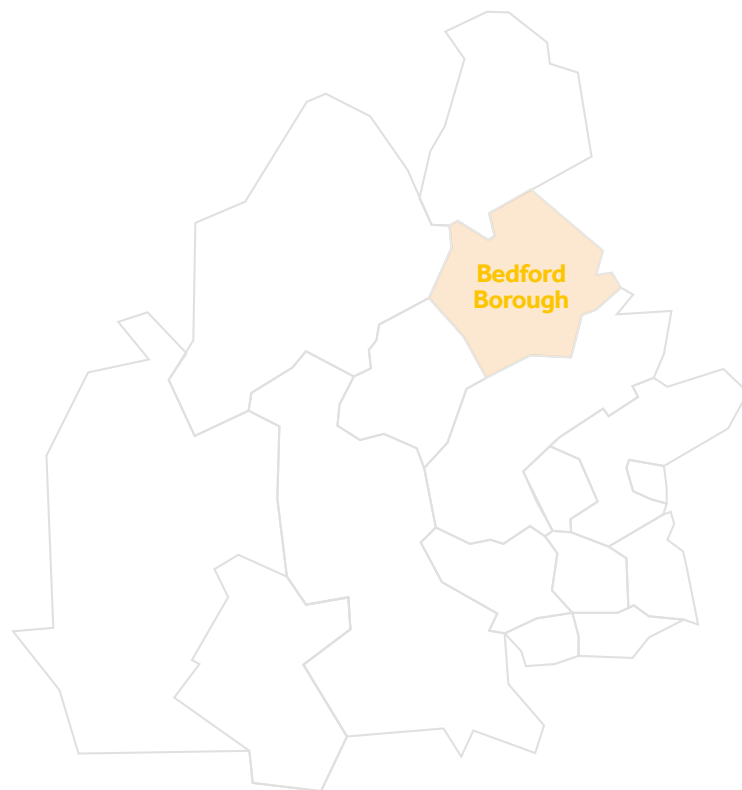
# Central Bedfordshire Local Plan

The Local Plan was adopted at Full Council on the 22nd of July 2021, the adopted plan can be found [here](#). As of September 2023, Central Bedfordshire Council have put forward a new Local Development Scheme whereby the Council outline their timeline for undertaking a Full Local Plan Review. Informal/ non-statutory engagement and evidence review is scheduled to take place between September 2023 – February 2024. # Bedford Borough Local Plan

Bedford Borough Council has submitted the draft Local Plan 2040 to Secretary of State in January 2023, with the Examination period taking place in September. The Council have submitted their responses to the Inspectors Actions arising from the hearing sessions which concluded on the 21st September.



# South Oxfordshire Local Plan

South Oxfordshire and the Vale of the White Horse (VOWH) are creating a Joint Local Plan 2041, which will supersede the SODC Local Plan 2035 and VOWH Local Plan 2031. The Council have undertaken a public consultation on issues and scope (regulation 18) and the responses have been analysed. The Preferred Options Public Consultation is due to take place in early 2024. The Local Development Scheme currently has the Pre-Submission consultation scheduled to commence in October/November 2024.



# St Albans Local Plan

St Albans City and District Council are preparing a new local plan. The Draft Local Plan Regulation 18 consultation closed as of the 25th September 2023. The Council will now review the consultation comments. If you are a landowner and require development advice, please contact our Land Planning and Development Team.



# Northampton Local Plan

The Council received the Inspectors Final report on 3rd February 2023 which was found to be legally compliant and sound, subject to Main Modifications. The Local Plan was approved for adoption on 23rd March 2023. The Council are preparing a new local plan to guide development up to 2041, the spatial options consultation concluded in December 2021, no decision have been made yet on where growth will occur.



# East Northamptonshire Local Plan

The East Northamptonshire Local Plan Part 2 is still being examined. The Inspector issued her Final Report to the Council on 31st July 2023 which concludes the soundness of the Local Plan. The Local Plan is anticipated to take place at the Full Council towards the end of the year.





# Buckinghamshire Local Plan

Buckinghamshire Council are beginning work on the new Local Plan in the period up to 2040 in Buckinghamshire. Buckinghamshire Council have now undertaken a 'Wider Call for Sites' and submissions are now being analysed. The Council have acknowledged there is a limit to how much progress they can make until National Policy is confirmed and a reliable timeframe is provided. # Stevenage Borough Local Plan

The Stevenage Borough Local Plan was adopted in 2019, replacing the District Plan. The plan seeks to provide around 7,600 new homes. The local plan can be viewed [here](#). It is likely that this Local Plan will not be reviewed until 2024.



# Dacorum Local Plan

The Committee report dated 4th October 2023 has suggested the Regulation 18 consultation should take place between 30th October and 12th December 2023. Additionally, Dacorum district are developing a Joint Strategic Plan for the South West Hertfordshire area covering Dacorum, St Albans, Three Rivers, Watford and Hertsmere. # Welwyn & Hatfield Local Plan

The Examination period is still underway with the Proposed Further Main Modifications consultation being undertaken which ends at 5pm on 30th July 2023. The Inspector's report surmised that the Local Plan is sound and capable of adoption subject to Main Modifications.



# Hertsmere Local Plan

Hertsmere council have decided to 'shelve' their current draft Local Plan but will continue the plan-making process to take account of any planning reforms announced by the government.



# Watford Borough Council Local Plan

The Watford Local Plan has been adopted as of 17th October 2022 following the incorporation of modifications required by the Inspector. The local plan can be found [here](#).



# North Herts District Council Local Plan

The North Herts Local Plan 2011-2031 was adopted on Tuesday 8th November 2022, replacing the saved policies of the District Plan Second Review with Alterations. The local plan can be found [here](#).
