## DESCRIPTION

Units 1, 2, 3 & 5 Circle Business Centre consist of light industrial hybrid buildings which are part of a development of 5 units sat within a gated courtyard development, built in approximately 2001.

Unit 1 is predominantly office space with ancillary meeting rooms and staff facilities and has been fitted out to a high specification.

Units 2, 3 & 5 provide industrial storage and distribution space which have had full mezzanines fitted and benefit from ancillary office areas.

Externally there are accessible loading areas and associated parking spaces with each unit.

### LOCATION

Houghton Regis is a small town situated immediately to the north of Dunstable forming part of the Luton and Dunstable conurbation. The property is located on an industrial area of Houghton Regis along Blackburn Road which is on the outskirts of the town and within 1 mile of Dunstable town centre.


