#### Location:

Situated within the pedestrianised area of Upper George Street, a short walk from the Town Hall, and opposite one of the entrance to The Point. The property has access to excellent local and national public transport links including Luton's mainline station which is within walking distance offering access to London in 22 minutes as well as the North and the Midlands. Local road links include A505 leading to A6 (0.1 miles) and M1 J10 (1.7 miles).

## **Description:**

Comprising recently refurbished self-contained town centre office building over first and second floors. The first floor is made up of a reception/office area with kitchen and W/C facilities. The second floor comprises two further office rooms.
